To the registered voters of the City of San Angelo, Texas:

Notice is hereby given that the polling places listed below will be open from 7:00 a.m. to 7:00 p.m., on Saturday May 3, 2025 for voting in a general election to elect a Mayor and Council Members for Single Member District Two, Single Member District Four, and Single Member District Six for four-year terms; and a bond election for the issuance of bonds in the amount of \$41,660,000 for promoting economic development by renovating the City's Coliseum and Fairgrounds and the levy of taxes sufficient to pay the principal of and interest on the bonds.
